Summary of Impact Fees

The information below is a summary. Impact fees are assessed and collected according to the Thurston County Impact Fee Ordinance (Title 25) and the most current Impact Fee Schedule. Please check with Thurston County Resource Stewardship and/or Public Works staff for the most current fees.

--Impact Fees are used to fund new developments share of improvements to Parks, Transportation and Schools, that are necessary due the increase in residences, students and traffic related to new development.

--Impact fees will be assessed at the time a completed building application is submitted to the Thurston County Permit Assistance Center.

--Impact Fees will be collected at the time the Building Permit is drawn.

--Impact fees for transportation and schools are not uniform across the county, rather the fee amount is based on the projected cost of a capital projects within a school district or transportation district service area.

--Park's impact fees are uniform across the county.

--Development applicants may calculate the potential impact fee amounts by identifying the location of their project, and then summing the transportation, school and parks fee impact per development unit.
